### **Notice of Conditional Acceptance to Offer**

Dear recipients named above herein,

We are writing to give you notice that we will accept your offer to vaccinate us and our family members which you have recently advertised on main stream media as a public announcement and give you notice that is a conditional acceptance and will become binding when you are able to meet all terms and conditions. You have made an offer to contract and as a party to that contract we have the right to negotiate the terms of the contract you offer, as under rules of contract law, a contract must be beneficial to all parties and must not cause harm to a party or the contract becomes void and non-enforceable.

As living men and women we retain and reserve all of our God given rights including sole possession and sole use of all our biological materials which are granted to us by our Creator, therefore we do not consent to you offering us a medical product, including but not limited to an alleged COVID-19 ‘vaccine’ and any or all medical devices including but not limited to a face mask. We believe that both of these products will cause harm to us and we therefore reject your offer unless you can provide evidence of each and every point herein below. We retain the right to decline all attempts to access, influence and or otherwise alter any or all of our God given biological material and or biological systems which are the unique, flawless and original design and craftsmanship of our Creator and of which our Creator has granted us sole possession, proprietorship and use of.

We require that any or all product offered to us by my employer or workplace or doctor or all other agents of the government or acting for the government, both state and federal, that is as a condition for us to be employed, receive benefits, freely travel within Australia and outside Australia, enter business premises, sports and any or all other rights usually afforded to us, be both entirely retrievable from and also removable in its entirety from our body, person, womanhood and manhood at the first moment we make a private assessment that the alleged vaccine and or mask or medical device or treatment of all kinds is causing harm to us.

Pursuant to the above statement, we will decline the offer for vaccination product or offer to wear a mask and retain all our rights unless the following conditions are met in entirety, please provide evidence of each and every point of the following by duly witnessed affidavit of facts;

1. Your right under the Commonwealth of Australia Constitution Act 1901, section 51(xxiii)(a) but not so as to authorize any form of civil conscription, or force or coerce or apply undue influence on us to receive a medical product, and
2. Your right under the Public Health Act of every state to force, coerce, under undue influence to demand we wear a mask or be vaccinated to attend our workplace and carry out our usual duties, and
3. Your right under the Privacy Act 1988 to appoint officers and agents to request our private medical records and medical condition without following due process, and
4. Your right to allow police and or agents of or for the government to issue directions or fines or charges or to use undue influence, coercion, force or intimidation in an attempt to force compliance of your rules us for a medical condition that has not been diagnosed by a doctor, and
5. Your right under the Fair Work Act 2009 to force, coerce or use undue influence to demand we wear a mask to attend my workplace (in a workplace that has not been required to wear a mask prior to March 2020), and
6. Your right under the Fair Work Act 2009 to force, coerce or use undue influence to demand we wear receive a COVID-19 vaccination or flu vaccination to attend my workplace that was not previously a requirement to work prior to March 2020), and
7. Your right under the Fair Work Act 2009 section 336(b) that provides us protection from workplace discrimination if we do not wear a mask and do not receive a vaccination, and
8. Your right under the Fair Work Act 2009 section 343 to use coercion or intimidation of all kinds to force us to wear a mask or to be vaccinated, and
9. Your right under the Fair Work Act 2009 section 344 to apply undue influence to force us to comply with your direction wear a mask or to be vaccinated, and
10. Your right under the Fair Work Act 2009 section 351 not to discriminate against us for my private decision not to wear a mask and not to receive a vaccination, and
11. Your right under the Fair Work Act 2009 section 382 to allow or encourage an employer to dismiss us from our employment for our private decision not to wear a mask and not to receive a vaccination, and
12. Your rights under the Universal Declaration of Human Rights (UDHR) to override our rights in this declaration, in particular reference to Articles 2, 3, 4, 5, 7, 8, 18 and 23 which have been used to create the Human Rights of each state of Australia, and
13. Please provide evidence that the WHO (World Health Organisation) has provided you with scientific safety reports that the wearing of masks is safe for us to use in the workplace, in our cars and in public places (United Nations Universal Declaration on Human Rights Article 5. No one shall be subjected to torture or to cruel, inhuman or degrading treatment or punishment), and
14. Provide us with all evidence showing that the WHO has provided you with scientific and peer reviewed safety reports published in medical journals that the flu vaccination and the COVID-19 vaccination (for every product you wish to use in Australia) have been proven 100% safe and 100% effective (United Nations Universal Declaration on Human Rights Article 5. No one shall be subjected to torture or to cruel, inhuman or degrading treatment or punishment), and
15. Please provide evidence of the scientific and peer reviewed safety reports published in medical journals proving that wearing of mask causes no harm and carries no risk of bacterial infection by breathing in one's own expired breath (The United Nations Universal Declaration on Human Rights Article 5. No one shall be subjected to torture or to cruel, inhuman or degrading treatment or punishment), and
16. Evidence that the PCR test or all other test being used to allegedly identify what is commonly claimed to be corona virus or COVID-19 is 100% accurate when diagnosing a COVID-19 reportable virus , and
17. That the PCR test or all other tests being used to allegedly identify what is commonly claimed to be corona virus or COVID-19 is 100% safe and will not cause harm (The United Nations Universal Declaration on Human Rights Article 5. No one shall be subjected to torture or to cruel, inhuman or

Please provide evidence detailing how your government has represented the Australian people with IATA, International Air Transport Association, and reinforced our rights to travel freely and without discrimination of medical condition or health status as was our right given to use by the Queen Elizabeth II and is stated in our Australian passports for international travel as we were unaware of an announcement to the public to make our voice heard with our representatives on this matter, and
28. Please provide evidence detailing how your government has the authority under the Commonwealth of Australia Constitution Act 1900, section 69, to enforce use of a phone App, phone tracking, or tracing via a phone, and
29. Please provide evidence detailing how your government has the authority under the Commonwealth of Australia Constitution Act 1900, section 109, to enforce any law that is inconsistent with a law of the Commonwealth.

You agree that all liability for harm or injury rests with you jointly and severally as living men and women, and with your heirs and successors, as you are representing the government and that any liability shall not be waived or passed to another person or agent or department and will remain as a liability of your personal and private estate, and if

The United Nations Universal Declaration on Human Rights has reinforced our God given rights and for any breach of these rights, including but not limited to;
- a. **Article 3.** Everyone has the right to life, liberty and security of person.
  - b. **Article 4.** No one shall be held in slavery or servitude; slavery and the slave trade shall be prohibited in all their forms.
  - c. **Article 5.** No one shall be subjected to torture or to cruel, inhuman or degrading treatment or punishment.
  - d. **Article 6.** Everyone has the right to recognition everywhere as a person before the law.

All breaches or restriction of these Universal Human Rights you will agree to a payment of fifty million dollars (\$50,000,000 AUD) per incident, per person, payable within 7 days.

As you are requesting, insisting, forcing and or coercing us to wear a medical device and or to receive a medication of the type commonly named flu vaccine COVID-19 vaccine (or any other name of product being administered as a COVID-19 product), as a requirement for our continued enjoyment of life, we will give you 21 days from the date of this notice to provide us with the sworn evidence of all points above numbered 1 to 29 and your full agreement to points 30 to 44, during which time our employment, benefits, freedom to travel and freedom to enjoy our lives without restrictions will remain as they should be, free in every sense of the word. [Maxim of law – the burden of proof is with the one making the claim]

Only a reply that meets the following criteria qualifies as a proper and verified reply;

1. It must be supported by an Affidavit with full legible name, title and wet ink signature and address for service, sign and sworn or affirmed by any claimant as being true, correct, complete, certain and not intended to mislead and under the claimants full commercial liability and penalty for perjury and must answer each of the above points 1 to 29 and agree to the above points 30 to 44 point by point in this Notice, and
2. Must include full and detailed supporting evidence to support your claims in the affidavit.
3. Incorrectly addressed mail will be returned unopened and unread without dishonour. All correspondence must only be sent by Registered Mail to ensure a record of delivery. Without such evidentiary record, Claimant should not take or fail to take any action that is based on the supposition that such correspondence was received. If the Claimants do not take or fail to take such action, they are liable for all resulting charges or damages they caused us.

It

is also agreed by your acquiescence that our terms and conditions for damages for injury or harm of all kinds, addressed in the points 30 to 44 above will take effect from 7 days from the date of this notice and will remain in place for the period of our natural life.

You will agree to provide us and our immediate family members with written exemptions to all of your rules, codes, directions and statutes, and any hidden or undisclosed restrictions that may have an impact on our rights and freedoms to travel freely, be employed, carry on business and the peace and enjoyment of our lives.
